The following are the terms and conditions for the LBF Australia Pty Ltd Sponsor A Friend Promotion (Offer). These terms and conditions are subject to the LBF General Conditions of Subscription, which are attached and available on the LBF Australia website through the following link www.lbf.com.au. The Offer starts on 01.01.2012 and finishes on 31.03.12. To be eligible to receive the two months free subscription with LBF, the sponsor must be a current LBF subscriber (Sponsor) and must refer the relevant LBF service to an individual in Australia (Friend).
